Commissioner Fletcher Survey Recommendations

FY 2024 Housing and Community Development Needs Survey Workshop: Extensive discussion was had by the Commission regarding the survey and possible improvements that could be made to this year's survey and survey process. The Commission suggested ranking priorities on the survey, and dividing the rankings by CDBG and HOME funds.

Rose inquired if Dr. Aida Guhlincozzi had sent her survey questions to staff, Clark shared that staff has not received them but will follow up.

Teddy shared that staff will create a draft survey based on the suggestions made tonight and bring it to the next meeting for revision.

Rose suggested Commissioners think of five outlets or places for survey distribution and bring those to the next meeting for discussion.
